Privacy Statement

The Kamloops YMCA-YWCA is committed to protecting personal information by following responsible information handling practices in accordance with privacy laws.

The Y uses modern information and communication technologies to support our activities. Our Privacy Statement covers the YMCA -YWCA and our website.

Our Policy

As a general policy no personal information is collected from our Website visitors. However, as with most sites, certain non-personal information is recorded by the standard operation of our servers (cookie technology). Such information is used to provide an enhanced online experience and may include:

- ◆ The name of the ISP from which the site was accessed
- ◆ The date and time the site was accessed
- ◆ The internet address of the Website used to enter our site and the Website used after leaving our site

This information is also used to measure and monitor the use of our site and to improve its content. The “cookie technology” does not personally identify individuals or extract any information from their computers.

Links

Our Website also provides a number of links to third party sites. The Kamloops YMCA-YWCA assumes no responsibility for the information practices of sites accessible through our site. We encourage visitors to review each site's privacy policy before disclosing any personal information.

Your choice

In order to better meet our members program, service and information needs, we request personal data when you make use of/or register for our programs and services.

We also use and disclose statistical data, which does not identify individuals, for the purpose of developing and enhancing Y programs and services.

Additionally, we may also collect personal information in order to satisfy legal, government and regulatory obligations.

If you supply us with contact information, we may contact you with information concerning the Y program or service in which you are registered.

You may also hear from us about other Y programs and services that may interest and benefit you.

Information sharing

We do not sell personal information we collect.

We will not disclose your personal information to anyone else without your prior knowledge or consent, except when required by a government body or agency, or as permitted by law.

Children's Privacy

The Kamloops YMCA-YWCA, in keeping with our Mission and Vision, believes in the development of healthy, confident children.

We will obtain permission from a parent or legal guardian regarding the collection and use of personal information about children under 12 years of age.

Confidentiality / Security

The Y maintains physical, electronic and administrative safeguards that are appropriate to the type of personal information we obtain.

Kamloops YMCA - YWCA staff and volunteers with access to personal data are required to respect the confidentiality of personal information and trained to handle it responsibly.
